Hi Charlotte,

I believe the proposed statement is generally fine, especially since it includes a reference to Article 23. I suggest (1) eliminating the statement that "Academic Freedom violations shall have the benefit of due process." This is ambiguous, and a better description of faculty protections are set forth in the CBA. (2) I suggest changing the Article 23, as revised below, and also including a reference to the parties' negotiated Academic Freedom Statement in the appendix to the CBA.

Alternatively, is there a reason why LPC has elected to create its own statement, rather than just use the parties' negotiated academic freedom statement? http://www.clpccd.org/HR/documents/AcadFreedomStatement 000.pdf. I realize this is for the catalog, but the full statement is only a single page, and using it would better ensure consistency among the District's various references to academic freedom.
