III. CDTC stipends for coursework and work permits.

- (1) \$39 per unit, last day to apply is Oct. 21
- (2) If working with young children, they qualify for this grant (if taking classes) or enrolled in the ECE 90 class.
- IV. Learning community/cohorts' updates
- Inclusion grant free enrollment and textbooks for completing the 2 courses on children with exceptional needs (ECE 60 + 91) = receive a stipend for successfully completing the two courses (2nd cohort begins, fall 23)
