Frequently Asked Questions

What if I filed the FAFSA by accident and I am undocumented with AB 540 status?

- 1. Complete the California Dream Application
- 2. Complete the Application Conversion Form G-55: www.csac.ca.gov/post/applicationconversion-form

Am I required to register for Selective Service?

If you are a male between the ages of 18 and 25, in most cases you are required to register with the Selective Service System (SSS) and show proof of registration to your college or university before receiving state financial aid. The SSS does not share your immigration status.

No, you must attend at least one class in-person at Las Positas or take a hybrid class.

AB 540 Students **Qualify for** State-Sponsored **Financial Aid and Programs**

Students must meet the following requirements to qualify:

1. Attendance

Requirement (minimum)

• 3 years of high school, adult school, community college or any combination of the above in California (CA)

OR

- 3 years of high school coursework and attended a combination of CA elementary, secondary, and high school
- 2. Completion of a course of study (at least one)
- CA high school diploma, CA adult school, GED or the equivalent (HiSET, TASC, CHSPE)
- Degree from a CA Community College
- Fulfilled minimum transfer requirements to a UC or CSU Campus

Step 1: Establish AB 540 Status With Admissions and Records

After you've applied to Las Positas College, you must submit one of the followina:

For DACA students and/or students who have lived in California for at least 366 days prior to the start of the term:

A Change of Residency Form www.laspositascollege.edu/admissions/assets/docs/ReclassLPC2017.pdf OR

If you are undocumented or don't meet the above-mentioned criteria: Official high school transcripts and an AB 540 Affidavit www.laspositascollege.edu/admissions/assets/docs/AB540-FORM-2018.pdf

Steps for High School Seniors in California:

Step 1: Submit your AB 540 Affidavit and unofficial transcripts. Step 2: After you graduate from High School, please submit your OFFICIAL Transcripts with your graduation date.

Establishing AB 540 Status means that if eligible you will pay \$46/unit and not \$336/unit. You will also be eligible for other state assistance.

Step 2: Apply for Aid at Las Positas

1. Submit the California Dream Application (*dream.csac.ca.gov*)

- LPC's Federal School Code: 030357
- Apply by March 2nd or September 2nd to be considered for a Cal Grant
- If you miss the Cal Grant deadlines still apply, you will be considered for a registration fee waiver and other grants

2. Submit a GPA Verification Form to the California Student Aid Commission (CSAC). If you have completed 16+ units of college-level coursework at LPC the Financial Aid Office will send your GPA automatically to CSAC. If you have not completed 16+ units of college-level coursework at LPC, contact your high school to complete a Cal Grant GPA Verification Form (www.csac.ca.gov/how-apply).

3. Submit any required forms indicated in your CLASS-Web and complete your file if you are Cal Grant eligible.

Your information will NOT be shared with the federal government.

Financial Aid Assistance at Las Positas

If you are AB 540 eligible you may be considered for a fee waiver, various state grants, and scholarships.

Fee Waiver: means your enrollment fees are paid for. It is not a cash value. • California College Promise Grant (CCPG) formerly known as the

Board of Governors Fee Waiver (BOGW)

Grants: are awards based on financial need that do not need to be paid back.

• AB 19 California College Promise Scholarship, Cal Grant, SSCG1, SSCG2, and Chafee Grant.

Scholarships: free money that you do not have to pay back, based on merit, talent, or affiliation.
