- We are concerned about the increase of positive Covid reports, and the lack of testing. The test facility at LPC has lines every day. VP Raichbart has contacted City Health, and they have agreed to be open 7 days a week. We are monitoring data regularly.
- The hybrid workplace model is extended through January 17, with a campus return on January 18. Conversations with SEIU and constituency groups continue, and will do so through the spring semester.
- Dr. Foster's concern is assuring that we are thoughtful about making timely decisions with clear communications, here at LPC and throughout the district. Staff and students need to be informed so they can make plans.
- Dr. Foster will email reminders about people's different comfort levels, being mindful about social distancing, and wearing masks indoors.
- He encourages continued use of a zoom option for meetings, as our meeting spaces do not provide distancing.
- Please wear name badges and make sure you have a LPC staff identification. We will be provided with LPC lanyards. These measures are helpful for the vaccine check in tables.
- We have hired an independent contractor to conduct LPC contact tracing (this was previously the deans and managers' responsibility).
- Question: if an employee is exposed to Covid, and has symptoms, can they work from home? With symptoms, this will require using sick time. SEIU and the district are aware of this issue, and discussions continue. Link to district Covid information:
