Requirements:

All perspective Student Members-At-Large must have a cumulative 2.0 GPA and be enrolled in at least five (5) credit units at the time of application and throughout their term of office. It is recommended to attend Student Senate meetings held on Thursdays at 4:30 p.m. until adjournment.

Process of Senator confirmation:

The Program Coordinator for Student Life and Leadership or designee must verify academic eligibility after receiving the Member-At-Large Application. Once verified, an LPCSG Executive Board member and the LPCSG Advisor will schedule an interview. A prospective Member-At-Large is required to attend at least one (1) LPCSG Senate Meeting. The LPCSG Vice President will recommend the confirmation or denial of the Student Member-At-Large at a Student Senate meeting. Then a vote will be held to determine the prospective Student Member-At-Large confirmation or denial. If the Student Member-At-Large is not confirmed, they may be granted a one-month extension of their trial period. If the Student Member-At-Large is not confirmed after their second trial period, their Student Member-At-Large packet shall become voided. They may not reapply to the Student Member-At-Large for four (4) months. For more information, please review the LPCSG Bylaws on the Student Life Office webpage.
