- 3. Review and approval of Minutes from April 2023 meeting M/Sc approved
- 4. Teaching Winery Construction Update
 - a. Drone footage shown of the construction on the new Teaching Winery
 - b. Update from David: David was able to get into the new site recently. Exciting to see it after working to get this new site going for the last 15 years. Not a dream winery and some issues due to funding, but it will be perfect for a community college wine program. Safe, provides proper setting for instruction and has all main needs for instruction, etc. Big thanks to administrative

- team for moving forward. "If you build it, they will come." We hope to see a bump in students and want to make sure ribbon cutting is a big community event with media.
- c. Per David, earliest ribbon cutting would be summer of 2024. Darrel says fall of 2024 is more realistic. Hoping that they can keep things moving before the winter rains starts.

5. Vineyard Update

- a. Dialed back on vineyard due to upcoming move
- b. Sold some Albarino to Longevity
- c. Donated some fruit to student teams
- d. Picking some fruit on Friday (Syrah, possible Grenache as well) for a small batch of Syrah (maybe
 2 30-gallon barrels)

6. Wine Production Update

- a. Still have 126 gallons of Albariño in tank that needs to be bottled
- b. Tempranillo Rose from this 2023 already bottled
- c. Little bit of Graciano aging nicely
- d. Longevity didn't pick all of the Albariño. Maybe we could wait for higher Brix and do a late harvest Albariño?

7. Budget Update

- a. 2022-23 Year End Budget enclosed for Board approval
 - i. Year End Budget M/Sc approved
- b. 2023-24 Budget to Date enclosed for review
 - i. Already approved, just reviewing.

8. Campus Hill Winery Website

- a. Update on link from LPC Homepage?
 - It would be nice to have a link to the VWT program on the home page of the website.
 Very challenging to find program from home page of college. Anette will look into this option.
 - ii. David is asking for assistance with wine sales up at the new location. Sales are not consistent (sometimes 3 cases, sometimes 10+), but will be more difficult at the new place since we won't be at the center of campus anymore. Thoughts to try and get wine by the glass at Beebs or something similar? By the glass here?
 - Biggest thing that would help: Wine sales and wine "club" online!!! David might
 be able to find someone to donate their services to help us get a wine sales
 service set up online. Wine club would help with online sales. People shop
 online and then have to come pick up at the new location. Need to figure out

- what club details would be and then have cards to fill out so that people can take it with them.
- From Anette: Who built the current VWT website? In order to have wine sales,
 we might need to have a VWT Foundation page. Wine sales cannot be directly
 linked to the college website. We can LINK from the VWT website/campus Hill
 Winery website to the foundation/wine sales page.
- 9. Statewide Association of Community Colleges (SWACC) Auxiliary Organization Liability Insurance Policy
 - a. Update on policy coverage?
 - b. David asked for an update on SWACC are we paid up? Anette will look into it. She has not seen a bill and will look to see if the district received and paid the bill. We have not had anyone ask for payment.
- 10. Livermore Valley Wine Growers Association opportunities
 - a. Goal is better relationship with the LV association
 - b. From Norm: LVWC recently went through major changes. Executive director is gone, new director hired internally. Usually didn't have much money to help support local wineries, but just added the 2% tax to help increase funds.
 - c. They now have a scholarship fund "Genius Grows scholarship program". \$5k scholarship for 4 students. "Intended" major. Does not list Viticulture or Enology major as a requirement. Very vague and student can be from anywhere or attending college anywhere. Why is all this money collected from local wineries going toward a scholarship where the student doesn't go to a local program? Why are they not awarded a scholarship to LPC? David is planning to chat with Brandi to get more information.

 - CT-TR-1 must accompany RRF-1
 - IRS 990N must accompany RRF-1

12. Winery Compliance

- a. Licenses: renewed, current and posted.
- b. Federal Winery Filings and Excise Taxes: current.

- c. CA State Winery Filings and Taxes: current.
 - CDTFA 501 Winegrower Tax Return (State Excise Tax) due by January 2024
 - CDTFA Sales & Use Tax current
- d. CA Department of Food and Agriculture (CDFA) Grape Crush and Purchase Inquiry Report due by Jan 10 for previous harvest.
- e. CDFA Pierce's Disease, Grape Crush, and Grape Acreage Report and assessment due by Jan 10 for previous harvest.
- f. CA ABC Responsible Beverage Server (RBS) Training every 3 years is required as of August 2022 for servers and managers. Any on-premises alcohol server or manager must register in the RBS Portal, take training from an authorized RBS Training Provider, and pass the ABC Alcohol Server Certification examination within 30 days of completing the training. Servers and managers must be certified within 60 days of their first date of employment. David completed RBS July 2022.
 - i. Damien will need to get certified as a "Manager". He or David will be required to be present when anyone is pouring Campus Hill Wine on campus.

13. Community Outreach and Promotional Events since last meeting

- a. Intercollege Wine Invitational held June 9-10, 2023 at Allan Hancock College. Las Positas placed well in wine judging.
 - i. David was not able to attend but sent two students to attend. Students did a great job setting up the tables. The wines placed very well in the competition – LPC wines beat out Napa Valley college and Allan Hancock College's wines.
 - ii. Allan Hancock was very generous in putting up all students who poured AND paying for their dinners.
 - iii. David would like for this event to move locations each year to different local colleges
- b. LPC Summer Theater Event *Footloose* held 2 weekends in July, 2003. Sold \$4400 in wine. Cost for supplies/glasses/permits totaled \$674.
 - i. Licensing was difficult to get and cost a little bit of money. But the event was successful overall. Stemless plastic cups were purchased. The play was fun, no one got hurt, and sales were successful. Great to sell over \$4k in wine.
- c. Tri Valley Educational Collaborative (TEC) Career Tech Mixer held at LPC Horticulture Facility September 2023. Donated 1 case of wine.
- d. October 20 CARE Chabot Las Positas Association of Retired Employees Luncheon. Campus Hill
 Winery wines will be tasted and David is a guest presenter.
 - David will be talking about the new building. A case of wine will be purchased as well for raffle prizes.

- e. Donating wine for the ribbon cutting of the 2100 building (Academic Support). Inside the lobby of the 2100 building on November 17th great opportunity to showcase the wines.
 - i. Darrel Looking for glasses for this event. Should the stemware be purchased? Problem with purchasing is washing the glasses and also have to be hand polished. Renting glasses is an option pro: don't have to worry about washing glasses, con: glasses might walk away. Govinos are another option: pro: recyclable, don't have to wash, people can take with them, con: not as nice as glass.
