The Las Positas College (LPC) EMS Programs prepares individuals to become paramedics. A **Paramedic** is an allied health professional whose primary focus is to provide advanced emergency medical care for patients who access the emergency medical system. This individual possesses the complex knowledge and skills necessary to provide patient care, give accurate verbal reports to other healthcare providers, generate accurate written documentation within specified time periods, and transport patients safely.

The Paramedic program at Las Positas College is an 18-month special admissions program.

College credit is awarded for successful completion of each course in the EMS program. These credits can be used towards an associate degree in Emergency Medical Services (EMS) or a Certificate of Achievement through Las Positas College. As the paramedic program courses are approved by the State Chancellor's Office, Financial Aid is available to qualified students. The estimated total cost of the program ranges from \$4,472.00 to \$17,520.00. The cost of the program includes tuition of \$46.00 per unit for California Residents or \$360.00 per unit for nonresidents or international students plus additional costs of approximately \$3000.00 to \$6000.00. ## LPC Paramedic Program Objectives Acknowledgement Form

To achieve the LPC Paramedic Program objectives, a student must be able to:

- Assist in lifting and carrying injured and/or ill persons to and from the ambulance.
- Engage in pushing and/or pulling to assist in extrication of a patient pinned beneath and inside a vehicle, and in vehicles with electrical hazards.
- Walk, stand, lift, carry, and balance in excess of 125 pounds without assistance, (250 pounds with assistance) while lifting, pulling, pushing, and carrying a patient.
- Stoop, kneel, bend, crouch, and crawl on uneven terrain to gain access to a patient.
- Climb stairs, hillsides, and ladders to gain access to a patient.
- Communicate verbally in person, via telephone, and on radio equipment.
- Work in chaotic environments with loud noises and flashing lights.
- Perform patient assessments, implement treatment, and calculate weight and volume ratios under potentially critical time constraints.
- Work effectively in low light, confined spaces, extreme environmental conditions, and other dangerous environments while remaining calm.
- Perform fine motor movements while in stressful situations and under threatening time constraints.

- **June 23<sup>rd</sup>** – Notification your application is complete and has been accepted and are eligible to take the Fisdap Paramedic Entrance Examination at Las Positas College at one of the examination sessions that will occur from June 26<sup>th</sup> and July 3<sup>rd</sup>
- **July 14<sup>th</sup>** – Notification of acceptance into the program. Acceptance is based on a complete application, your Fisdap score meeting a minimum score, and if necessary, a lottery selection
- **August 1<sup>st</sup>** – Background, Medical and Drug Testing Due
- **August 18<sup>th</sup>** – Program Starts
