- **Potential CurricUNET Changes** **Craig Kutil**
The committee reviewed the methods of instruction in CurricUNET. It was questioned whether some options would be considered more methods of evaluation. It was decided to remove several redundant options.

8. Report

- **Vice President's Report** **Kristina Whalen**
Kristina Whalen stated that the Annual Curriculum Approval Certification Form was submitted to the Chancellor's Office, which states that we are following their guidelines and allows us to maintain local approval. This is signed by the Curriculum Chair, Academic Senate President, VP of Academic Services and College President.
- **Chair's Report** **Craig Kutil**
Craig Kutil stated that a number of programs will be updated administratively before the end of the semester to account for course updates and deactivations. There has been some questions regarding our Liberal Arts & Sciences degrees. To clarify, while he currently updates the curriculum to reflect any course changes, program review and course substitutions are done by designated discipline faculty. These programs are not transfer oriented. It has been clarified that the UCTPs will not fall under the category of transfer, instead they will have a goal of Local-Transfer Oriented. The guidance has been to hold off currently on UCTPs until further clarification is received from the UCOP and Chancellor's Office on several outstanding issues. Starting Fall 2020 the Chancellor's Office will start auditing the COCI, to verify that all programs are compliant. They will only be looking a subset of programs. If an issue is found, we will then have 60 days to address how we plan to fix the issue. The auditing includes AD-T's which, though already reviewed by the Chancellor's Office before approval, an initial audit of over 500 AD-T's has shown that only 29% are in compliance. We have receive a clarification that our AD-T double counting should be included in the catalog and will be added for Fall 2020. If a TMC is updated, we do not need to update if

there is no significant change. However, for example, the Business Administration AS-T update will be significant and we will be required to update the program.

- **Articulation Officer's Report**

Craig Kutil

Craig Kutil specified that another CSU campus reached out to him to let him know that a student transferred with an AD-T without completing the public speaking requirement. While they did not withdraw admission, the student had to complete the course at the CSU campus. At another campus several students were denied admission with an AD-T for not completing the public speaking requirement. Due to this issue, there needs to be more oversight by the Articulation Officer with regards to AD-T course substitutions.
