- Department Name & Descriptor Change:
 - Kinesiology- *Presented by Craig Kutil* This may not move forward, as the Kinesiology faculty are still debating whether they would like to move forward. Changing the descriptor for the Physical Education courses, would allow high school/middle college students to enroll in the actual kinesiology theory courses. Currently A & R does not have a way to differentiate. This may come back at the next meeting for discussion.
 - Mass Communication- Presented by Melissa Korber- Current Name: Mass Communications (MSCM) Proposed Name: Journalism and Media Studies (JAMS). An underlying cause for the decline in enrollment in the program may be confusion about the department's name. The speech department program rebranded as Communication Studies, in part because the ADT. Several students in the Mass Communications classes indicated that they were Communication Studies majors but wanted to be journalists. On the Journalism Association of Community Colleges listserv for journalism educators several other colleges have seen the same trend and already have made changes. In addition, of three most common transfer destinations for Las Positas College journalism students, none is specifically called "Mass Communications", instead "Journalism" or "Medial Studies." 8. General Education

For our AS degrees we currently require "Program-Based GE" to meet the Ed Code requirement of 19 units of GE. In looking at the reciprocity agreement, this is a policy unique to our college. Most other colleges require an actual GE area. Part of this may have been to stay at the minimum requirement of GE for AS degrees, as many of our programs are high units. According to new policy, students can also choose to follow the CSU GE or IGETC pattern to earn the AA or AS degree. In the process of looking at our GE Pattern areas, as Chabot initiated, we could look at adding an American Cultures or another GE area in place of the program-based GE. • Vice President's Report

Kristina Whalen has been published. In the current climate, there are constantly new items coming down from the state. The Distance Education Addendum has been approved for Fall 2020. A communication with guidance regarding the new P/NP policy and transfer implications is being drafted for students. The Curriculum Committee Chair position will be sent out to the faculty today as a matter of procedure for applications.

• Chair's Report

Elizabeth Owens stated that the 2020-21 catalog has been posted on the website. Catalogs are being printed for faculty, however there are some logistical issues that are being worked out for distribution.

• Articulation Officer's Report

Craig Kutil explained that CSU's are allowing P/NP for GE areas and major requirements for lower division. UC's have their own policies that are individual to their campus's. We should advise students to check with their transfer institution. For our middle college students, their A-G requirements, like a GE pattern, can all be taken for P/NP. He will let everyone know if more information is released.
