- They're modeling these after Chabot, ensuring that repeat & older community members can participate.
- Per Craig: There's typically an instructor specializing in teaching older adults [know how to deal with cognitive / physical deterioration etc.]. Will you do this? Dan – He doesn't see it as being a big problem; they're able to adjust their pedagogy (Maybe there is some professional development the instructor could do).
 - Per Elizabeth: Are there any State requirements about this [instructing older adults]? Not sure.
 - Per Kristina: Her prior institution had a program that specialized in this / creating community among older adults. There were specific modules and professional development around dealing with dexterity / physiological issues etc. [that spoke to the aging body & mind]. It's something to consider.
 - Per Kevin: At Chabot, they did have different supports for older adults – looking at how LPC's proposal would be viewed through an auditing lens.
 - Per Dan: Chabot is part of NASM, and they have to get everything approved by NASM before curriculum; and Dan modeled this proposed curriculum after theirs, so it's been rigorously reviewed.
 - Erick: How are we defining "older adult"? And for repeatability: What would folks' learning outcomes look like after they've retaken it so many times? Erick said he's happy to speak to Chabot's CC Chair.
 - Craig found the "older adults" definition in the PCAH, which he read aloud.
 - We need to ensure that the older adults language is included in the Catalog & the COR.
