- Process: Sarah Holtzclaw (District) reached out to him about it. The Teamsters have their own proprietary book etc. Brian speaks to their attorneys and turns it into an LPC class. He works with LPC & Teamsters on wording. It also went through Brian's advisory board & the Academic Senate.

# Committee Comments:

- CK: Why doesn't it mention the apprenticeship in the enrollment limitations? Also: Why is it 4 units for work experience? (*BH: Well, students could either attain all of the certificates or 1, 2, etc.*) Max is 8/semester; maybe it should be 1-8 units; repeat as many times as necessary /up to 16 units. Say 1-14?

- This CPL process was done last year with some CNT & AUTO courses.
- Process: There are 2-3 ways. They were searched by Sal last year through the ACE website. M.

Swanson has been training on MAP (Military A.P.) – it's preloaded with military courses /you can find what correlates. Steps: Find courses; approach faculty It's not as detailed as a COR. Faculty:

Approvals/app.dates. Everything is tracked and uploaded in CurricUNET.

- Goal: Have a CPL webpage like Palomar College's.

Committee Comments:

- EB: Our proposal was to streamline the work that Meghan is doing. Is the Committee okay with us submitting these as CPL Amendments (vs. Modifications)?
- CK likes the approach. He suggests just not listing all the ACE info on the CC Agenda.
- EWB: It doesn't seem necessary for M. Swanson to keep attending every CC meeting with CPL Amendments on the agenda. Also, EWB thinks the way CPL Amendments section appears is good.
- JG: Do certain levels of CPL need more input from CC? (Example: The JST's are articulation-based.)
- Meghan says she'll also be adding certification for AUTO.
  - > If we like, she can share /present at CC each time it's something different.
- EB: Are we okay with M. Swanson not having to attend?
- CK: We're really just approving the methods of CPL. It's not our role to do the articulation.
  - > It would be good to have the discipline faculty member at the Committee meeting.
- JG: Only 1 method of CPL is acceptable to UC, Credit by Exam? For the JST ones, students don't get credit [even though those courses are otherwise transferable to UC]? What's it say on the transcript?
  - CK: Palomar writes "Credit for [name CPL method]" on the transcript.
  - > JG will talk to Enrollment Services about this. Also, he needs to make sure his team knows.
  - ➤ KW: She's clarifying what this looks like /how it's indicated (and what everyone sees).
- EB wants to keep all of the detail in the Agenda –shows the level of work/detail we've been through. And he concurs that it would be nice to have the discipline faculty member in attendance for any Q's

# **Curriculum Committee Approved Minutes**

- CK: The decision was actually not because of AB 928. It was because of SCFF funding formula. Some things earned us more points. They went to the highest point in an academic year for a student. We've now seen an impact on these disciplines – our Arts & Sciences degrees are still highly sought; they could still earn multiple degrees. It should be embedded in the Program Map /help with Guided Pathways. Note: Area E will no longer be anything at the CSU (they don't want to add units) – they fully pushed back on making it a graduation requirement.

- EWB: Really, there is pushback happening?

- CK: Yes... But do we expect there to be a change? No.
  - He wrote the CalGETC pattern /what the UC & CSU entrance requirements are. He had Area E there. CSU was ready to give it up at the start. Once pattern approved, requested it be a grad requirement. CSU pushed back on adding grad requirements that didn't also count for GE.
- EB: Thank you. We'll continue to have this conversation as a Committee.
