They're going to cross-list NTRN 5 with KIN.

- There is nothing set in stone, but there are conversations happening around this.

Committee Comments:

- CK: The AB 928 committee would only have any say if the 3 academic senates do not approve the CalGETC pattern by May 31, 2023. It's moving to the UC Academic Senate; but the language is "may" for the UC system and "shall" for the CSU system.
- EB: Thank you. It does not seem likely that the decision would change.

Also, it's important to acknowledge that LPC has awarded record AA & AS degree conferrals in its history. And there has been an increase in the number of liberal arts and science AA degrees.
- They advocate for looking at a policy that maximizes flexibility.
- ACCJC peer review team: They applauded LPC for being so supportive of students.
- They would like additional data to be reviewed to see at what point enrollment started falling (maybe the departments concerned can meet with Rajinder and his team).
- Think more mindfully about how/when we offer courses (Fast Track, asynchronous, etc.)

Committee Comments:

- CK: There's not an additional 7 units. He's not sure why multiple degrees are being encouraged.
- MZ: It could be up to 7 units not everyone's completing American Institutions. RE: Students earning multiple degrees, she says that students graduating from LPC [many of whom are first-generation college students] is a big accomplishment.
- KW: She appreciates the discussion and the great arguments being presented on both sides. It needs to be what is best for the students, per MZ she supports that sentiment. Also: From where she sits, multiple degrees are great. On the other side, a number of students may not leave with *any* degree.
- MV: Thank you for your presentation, MZ. It seems that the CC's are moving toward transfer. But what benefits students in their lifetime /overall is important too.
- EB: It's a wait-and-see / let's get more data. We also must continue to support Health, KIN, NTRN and making our classes more accessible.
