Jennie Graham (Math faculty): She is here about today's Math discussion item. Looking at Title V, it states courses that satisfy this requirement must be at/above Intermediate Algebra. BUSN 33 uses very little math. She is aware that other campuses have approved courses like BUSN 33, but due to possible misunderstandings. She strongly disagrees with including BUSN 33. Math faculty hope that they are invited to the Curriculum table to future discussion, thank you.

Michael Peterson (Math faculty) – He thinks BUSN 33 is a fantastic class and everyone should take it, but it does not have a lot of arithmetic in it. They would be happy to partner w/ BUSN, e.g., in BUSN Statistics (like at Chabot College – There is more emphasis on business applications). Thank you.

- Question brought up by counselors / of concern to the Counseling Dept.
- A couple weeks ago, she met with a student [who's in her 60's] who felt discouraged about the math requirement. It has been 40+ years since she has had a HS-level math course. They discussed BUSN 33 as a prospective math satisfaction. She really just wants a local AA degree. Transfer GE is not necessarily appropriate for her.
- She wanted to see what the Committee thinks about this idea.
- She shared the Title V language ("comparable to...Intermediate Algebra")
- They looked at other CA community colleges, shared there were 8 colleges/examples (Cañada, Chaffey, CCSF, College of San Mateo, Copper Mountain, Fullerton, SBCC, and Shasta).
- Also: An additional 9 CA community colleges simply use broader language.
