- Per Chair Bell: This will be part of a noncredit certificate.
- Born out of AB 1705. Thinking about ways to help prior basic skills candidates /students
- There is ~70% percent success rate (and lower) in ENG 1A, which coincides with basic skills going away
- It is a support course for students for whom the entrylevel ENG course is too tough
- Creative writing too this is good for those who may want to pursue a career as an editor, etc.
- He is considering making this a <u>late-start</u> course so faculty have time to identify students who need writing help
- Advisory reqs: Really not necessary/critical for students to have these skills, but 1705-bound
- How about making it a corequisite?
- > CK: But then you keep some students from taking it.

Scott Miner presenting.

- He is trying to make the course sequence & course offerings easier to deliver and provide students with the opportunity to master different welding processes. He says that for the past 40 years, they have done things the same way. He is recommending an overhaul to better align with industry standards.
- Primary lecture content was scattered about amongst different courses (corequisites) he is combining these to make 2x 3-unit courses.
- He added some open skills labs to allow students time to expand their welding experiences/growth.
- There has not been sufficient time for lecture; it spills over into lab time trying to adjust accordingly.
- In welding, there is lots of cross-listing.
- Pipe welding was only offered on Saturdays before; now it can be offered during the week. And vice versa for the others (More WLDT courses could now be offered on the weekends too).

Committee Comments:

- CK: In his view, this is not equivalent to what they previously were (half of the courses) and you kept the same numbering. Shouldn't they be treated like new courses?
- Per Scott: The core subject matter is the same; they are not new courses. The difference between the beginning and the advanced courses really had to do with the welding positions (flat, horizontal, vertical, overhead). He's rearranging topics. Also, it's a matter of enhanced lab load for the faculty.
- Per Scott: Combined 61A and 61B w/ the pipe welding class Welding Ferrous Materials > Per CK: 61 should be a new credit course.

- Scott concurs. SM also wants to deactivate 61A, 61B, 62A, and 62B.

- Per Scott: Took 62A, 62B, 69A.: Nonferrous Welding (now called 61 & 62 those are new).
- Chair Bell: He wants to be mindful of the Committee. Can we bring these back for a Second Reading? > Several committee members concur.

 - > Per Bill: We can do Jigsaw, brainwriting, accessible materials (EB/Liz can add this in CNET.)
- Chair: There's a noncredit course without any advisory requisites. Does this make sense for one of the camps to have the advisory, but the other not to?

> *Per Bill*: They should be identical, same prereqs. When they were originally created, there were no advisory reqs.

- CK: If a course has both lab & lecture component, we have folx spell out what you're doing in each.
 - > *Per Bill*: They're interwoven / that's difficult to do.
 - > CK says he could take the top-level content; he is updating this now.
- CK/NH: Should the NCIS courses be mirrored?
 - > EB: We can bring these back for a second reading.
- CK: He hopes to have Requisites Process/Protocol as a Discussion Item in Spring '23 too.
