When we wrote the catalog description we were thinking students would want this certificate for multiple reasons. 1) it provides lateral support for students not taking remedial English, 2) it could provide support to students that want extra support, and 3) students may take it for future careers if they don't want to transfer but want to put it on their resume. This new certificate is comprised of NENG 210 and NENG 215; we'd like to change the numbering so students know which course to take first.
