The original proposals we submitted were reject by the CSU review process. Upon their denial, they replied with very limited feedback. Based on that limited feedback we made these changes to these two courses.

Craig: Last year we didn't have anything approved for Ethnic Studies. CSU sent out language based on all the denials and based on that we made the few changes that were detailed in the letter. The letter didn't provide any guidance on how to meet the requirements, just that it didn't meet them. We are hoping these new changes will work and satisfy the rubric for Ethnic Studies.
