#### Scott Miner presenting.

- Lab courses have traditionally taught 2 welding techniques per class– trying to make things easier. 6x 1-unit lectures scattered throughout program – trying to pull it all together into 2x 3-unit courses. Lecture classes formatted on type. (Teaching the same stuff, just trying to reconfigure it.)

#### Committee Comments:

- EB: It was taught by metal type before; this is really just a restructure of how the courses are being instructed.
- CK: We need to remove the program-based GE. Is any of the courses in there anything you want to keep? > Scott: No.  $\rightarrow$  CK will delete it from the degree.
- EB: Are SLOs ready to present? > SM: Yes, Liz/John have them and he'll present them to the SLO Committee in Nov/Dec.
- EB: For 67L: Skills' importance listed as <u>critical</u>, but advisories noted as Recommended. Should be prereqs?
   SM: They should be recommended. He doesn't want folks /incumbent workers to be excluded. He'd have a conversation with the prospective student.
  - > EB: It seems that they should have some demonstrated proficiency.
  - > SM: How about "or instructor approval" language?
  - > CK: He'll always have to do an override if it's a prereq. The easiest way would be Rec. but switch skills level to "Very Helpful" (vs. Critical). > SM okays this.
- EB: 67L can be repeated 4x? Reasoning?
  - > SM: There are potentially 4 different welding processes... This is not unlike the already-approved courses like Jazz Lab. This is someone coming in to practice with equipment.
  - > CK: Those MUS courses you mentioned are required for a particular 4-year degree /that's why they're repeatable. The repeatability shouldn't be 4x (violates Title V).
  - > EB: Maybe make it 67L A,B,etc.
  - > SM: Fine, let's do A,B,C,D repeatable 1x.
- CK: We should spell out "Laboratory" (AL's, BL's, 67A-D) > SM okays this.
   → Liz can do this update course titles for the next Agenda & in CurricUNET.
- CK: With your modifications/updates, the degree will be 61 units. > SM: That's fine.
- EB: Very little differentiation between AL & BL.
  - Change "practical"  $\rightarrow$  advanced? And is that enough of a difference?
  - > *SM*: *The only difference is the position of the pipe /much more challenging.*
- CK: Is this all in the programs?
  - > *SM*: *It's complicated /trying to get it cleaned up.* #*s need to get updated in the programs.*
  - > They discussed SM's requested updates  $\rightarrow$  *CK will make these updates.*
- EB: Equity-based learning: Generality that everything is free from bias. Can you describe in more detail how?

> SM: In WLDT, everything we touch has rules/regs/standards/codes associated – takes the subjectivity out. The purpose is to create an environment of public safety. The materials & all equipment is exactly the same for everyone. They try to accommodate those with physical limitations; they look at everyone as an individual. Also: Historically, it has been a predominantly male program; they are trying to get more women involved.

- > EB: Let's get this incorporated in the COR / how. *Liz/EB can add*.
- CK: 69AL & BL are mods of A&B? > *SM*: *Yes, just A&B added*.
  - > CK: We need to fix this in CurricUNET. Andrea needs to know these are updates to courses we already had. (CK: There are 2 proposal sets – we need to just have 1 set.)
