- Institutions have 180 days to implement. Required to update Curriculum Committee review process and following example deadlines/expectations. Revision of Curriculum Committee procedures to reflect new equity, inclusion, and UDL. For example, UDL will most likely will show up in assessments and methods of instruction; equity – how students have a chance to succeed; inclusion – designing how curriculum can be inclusive for everyone. Potential for a future Curriculum Committee policy of official review of how LPC is ensuring how we are integrating UDL, equity and inclusion within CORs.

#### 7.2. Lab Activities – Craig Kutil

- Proposal of changing field in Meta [Content > Lab Content (change to Lab Activities)]. CK: makes more sense to say activities because it is “what students are doing” in a lab as an activity versus simply content. SB: does this limit faculty/instructors and impede on flexibility of course content? CK: yes/no, it is already what is in the COR, but Lab Activities will specify what is being done vs. content is an overview. CL: if it doesn’t limit, why is it necessary to change the word to activities? CK: because lab activities requires it to be more concise, instead of simply copying and pasting the same content information. Curriculum Committee agrees with change to Lab Activities under Content.

- Change from Associate Degree General Education (ADGE) to Las Positas College General Education (LPCGE) since it is our own local GE pattern. Curriculum Committee agrees with change to LPCGE, effective for 2026 – 2027 Academic Year.

- Three of us will be attending ASCCC Regional Curriculum Meeting; hoping for feedback with implementation of CCCCCO information regarding COR changes.

#### 8.3. Articulation Officer’s Report – Craig Kutil

- Elementary Teacher Education: Nonintegrated Programs (AA-T) is postponed so FDRG can coordinate with other entities
- Biology FDRG will hopefully be asking for 66-unit pathway and UC Transfer Alignment- TBD
- CCNs for BIO- Anatomy/Physiology CCN is paused due to concern for prerequisite issues with C-ID. The question is are prerequisites needed? The big decision is getting institutions to add prerequisites or complete removal of all prerequisites for CCN implementation to match the C-ID. Looking at effect of institutions- TBD. DN: why can’t this be a consistent standard, why doesn’t CCN allow prerequisites at the college-level? CK: the student expectation is that the CCN prerequisite courses are the same at all CCCs.
- Business CCN Phase III – almost complete, but not all objectives are covered that are on C-ID; due to misunderstanding that C-ID has objectives and CCN phase III templates were created using outcomes.
