- ➤ 1-unit KIN activity courses. New class proposal, but the facility doesn't exist yet. New funding allocated to athletics will open beach sport courts for 2v2 setup in sand. Similar to volleyball, but no use of hands; players will use the rest of their body to return the ball over the net.
- Facility isn't expected to be open until 2027, courses won't be offered until Fall 2027.
- ➤ AC request to have courses be articulated and add to ADTs in time for Fall 2027; CK will keep Effective Term as Fall 2026 and will note it won't be offered until Fall 2027, Curriculum Comm. agrees.

Allows students to renew/exclude up to 24 units and is only allowed to do it once throughout a student's college career. The units will be excluded from students GPA and is beneficial for

- students applying to transfer to four-year institutions. Needs discussion/questions regarding eligibility criteria for when the renewal of failed grades can occur. The district changed the policy to be more flexible to help students. Proposal to add 12 or 20 + units taken after the most recent grade from which the student is seeking renewal.
- CS: will this change affect any affinity groups? JG/CL: unsure of any disproportionate effects, can discuss this later.
- ➤ JG: overall proposal to add subsequent time; CK: reminder that institutional policies can be stricter than Title 5 only, cannot be more lenient than Title 5 wording.

- ➤ NCY previously approved for competency courses and adding a required capstone class; some NCYs are built without a capstone and have two similar level classes. Will discuss with faculty regarding adding a required capstone class only for NCYs.
- After Title 5 changes are chaptered, institution has 180 days to implement changes required. Current proposal within Title 5 for Academic Renewal states there is no unit limit and allows for unlimited Academic Renewal, but it isn't approved yet.
