# Presenter: Jin Tsubota Effective Term: Fall 2026

- NTUT classes are noncredit courses for tutors that are employees of LPC. Revamped curriculum to suit the need for tutors.
- Discussion: CK what discipline is NTUT supposed to fall under because the new courses are listed under Education, and previously it was listed under Learning Assistance or Learning Skills Coordinators or Instructors, and Tutoring Coordinators. To keep courses under the discipline of Education the minimum qualifications of an instructor require a M.Ed. CK suggestion to keep previous discipline. JT and Curr. Committee agree.
- NTUT 201 Tutoring Theory and Practice I
  - Tutors practice direct instruction; checking for understanding and actively engaging students. The goal is for students to do the work.
- NTUT 202 Tutoring Theory and Practice II
  - Tutors teach problem-solving strategies.
- NTUT 203 Tutoring Theory and Practice III

➤ Focused on emotional awareness. Tutor is emotionally engaged with students, but learning how to handle frustration to avoid fundamental attribution bias. Tutors will assess student emotional needs and learn how to choose an academic strategy to align with student goals.
