Target marketing to the students to LPC and/or the OTIE. Could benefit in either venue but need to determine what is best for the student so that we don't lose them.

Nan Ho, LPC - shared out the certificate and degree matrix. The matrix leads to guided pathways for students to efficiently complete their educational goal whether Career Certificate, Certificate of Achievement, and/or Degree.

#### **Enrollments**

Nan Ho of LPC - Enrollments are not sustaining the program at this time.

#### Curriculum

Steve McConnell of LPC – Speaking to the new members from Manufacturing and Construction, pointed out coursework that would meet their industry needs.

Nan Ho of LPC – Role of advisory board is to provide the college with direction for new courses and/or course content keeping our curriculum current.

#### <u>Other</u>

Nan Ho of LPC – would be great for the advisory members to not only present to the OSH students but to students in other coursework (e.g. chemistry, allied health, biosciences).

RADS Teacher – Concerned that training is training and education is education where critical thinking skills are developed through student learning outcomes.

Amanda Shin of Clorox — Annual Safety Professional Development associations, good opportunity for LPC to exhibit; Thursday, March 7<sup>th</sup>; talk at monthly meetings is a good marketing tool as well.

#### 5. Recommendations from the Advisory Board

Discussion however no formal vote of recommendations regarding:

- explore equivalency opportunities with the OSHA Training Institute Education Center and development of approved Continuing Education Units;
- 2. to determine Credit by Examination standards for potential students; and, continue developing the Distance Education certificate (need 1 more unit);
- 3. to evaluate whether the AS degree curriculum meets industry standards given the four classes in RADS, possibly communications, safety law & regulations, and/or business classes could be included;
- 4. seek transfer opportunities at the CSU/UC's (e.g. Sac State, Fresno); and,
- 5. outreach to employers.

Update the certificate to include another 1-unit course to include Fire Science Extinguisher and Work Experience.
